

**NOTICE OF SALE OF TAX SALE CERTIFICATES ON DELINQUENT LAND & LOTS**

**The yearly Delinquent Tax Certificate Sale is governed by Chapter 140 Revised Statutes of Missouri (RSMo.), which is the final authority.**

This is not a mortgage foreclosure sale; we sell Tax Liens on Properties for Taxes due. Only our most delinquent parcels (AFTER BEING OFFERED 3 TIMES) are sold without the ability for redemption.

You should make yourself aware of some of the Missouri laws which govern your rights & responsibilities as a purchaser of property at a Delinquent Tax Certificate Sale.

**Finally, the Collector and her staff will not be able to help you understand or interpret the laws. The Collector and her staff are not attorneys and state statutes prohibit practicing law without a license. For interpretation of the law, consult an attorney.**
